Information for Parents – Summer Programme

This is followed by a full-time non-residential week where the teams will plan their social action projects, and then a minimum of 30 hours of activity going out and implementing those projects. After the summer programmes have been completed, the young people will attend a final graduation event to celebrate their success, the location for this will be confirmed upon completion.
